Key terminology			
Daily supply charge	A charge that applies for supplying electricity to your property for each day of the billing period, regardless of how much electricity you use.		
kWh	'kWh' stands for kilowatt hour and is the unit of measurement for your electricity usage.		
Conditional Discounts			
13% Pay-on-Time	13% Pay-on-Time discount applies is conditional on the bill being paid by the due date. It applies to the energy usage portion of your bill and is off our standing offer usage charges (as shown above), not including Optional Green Extras or other fees.		
Price changes			
Charges may vary	We may vary the Charges (including the amount, nature and structure of any of the charges) by notice to you at any time. The notice could take the form of a message on your bill and will specify the effective date of the variation.		
Contract details			
Cooling off period	You may cancel this contract at any time during the 10 business day cooling off period.		
Eligibility	The offer set out in this Energy Price Fact Sheet is only available to residential electricity customers who consume less than 100 MWhs of electricity in the relevant distribution area with the necessary metering system/configuration.		
Fees			
Disconnection / reconnection fee	A \$93.19 (GST Incl) fee may apply when your property is disconnected or reconnected (including when you move). This fee is passed through from your distributor and may vary. Please visit your distributor's website to find out the current fee.		
Dishonored payment fee	A \$15.00 (GST Incl) fee may apply if your cheque payment is dishonored or reversed.		
Over the counter payment fee	\$2.00 (GST Incl) for over the counter payments at Westpac.		
Payment processing fee	A 0.6% fee (GST Incl) may apply to bill payments made by VISA or MasterCard.		
Distributor charges	You must pay us any charges that your distributor imposes on us in relation to the services performed by your distributor (or any other person) at your supply address.		
Paper Bill Fee	\$2.00 (GST Incl) applies for each paper bill.		
Smart Meter Fee	\$0.25 /day (GST Incl) per single phase smart meter or \$0.34 /day (GST Incl) per multi phase smart meter.		
Solar feed-in tariff			
Solar feed-in tariff	Enova offers 9 cents per kWh exported GST-exclusive (if any). To be eligible for this plan, your solar PV system may be of any size and may have any metering configuration.		
Optional Renewable Extra	Optional Renewable Extras: GreenPower, Community Renewable Energy, Renewable Development Initiative		
GreenPower 100	For an extra \$0.080 per kWh (excluding GST), 100% of your electricity purchased is matched with electricity from government certified renewable energy.		
Community Renewable 100	For an extra \$0.036364 per kWh (excluding GST), 100% of your electricity purchased is matched with electricity from Enova's community of customers with rooftop solar, solar farms and gardens initially, and eventually wind and other renewable sources.		
Renewable Development Initiative	For an extra \$2.00 per week (excluding GST), this contribution is dedicated to the Enova Renewable Energy Initiative to support community energy projects.
