The details in this pricing and product information statement are for a Residential customer in the **Powercor** Distribution Zone area with a Single Rate, Two Rate or Time of Use meter type. Rates are subject to confirmation of your meter type.

Rates and/or terms and conditions may vary to reflect business conditions, network charges or Consumer Price Index. If we have to vary your prices this will be done in accordance with the terms of your contract with us and the electricity law.

If you are eligible, you can apply to receive Government concessions or rebates.

When you enter into a market contract with us, your contract may be subject to a 10 business day cooling-off period. If one applies, your market contract will set out how you can terminate the contract during the cooling-off period.

- You may be placed on either a monthly or quarterly billing frequency. Confirmation of the frequency will be set out in your contract
- A payment processing fee of 1% (GST inclusive) may be applied if you pay your bill by credit or debit card
- We will provide you with an Electronic bill (eBill). However if you would prefer to receive a paper bill a charge of \$2 GST inclusive (per bill) will be applied to your account
- Flexible Pricing Information By choosing this tariff you may not be able to revert to your original tariff, but there will be a flat rate tariff available to you, except in some circumstances, which may include where you have a solar PV system. If you move retailers you will not be able to revert to your previous tariff.
