kWh: a 'kWh' stands for kilowatt hour and is the unit of measurement for your electricity usage.

Discount – Direct debit	3% discount on daily supply charge and usage rates where full payment is made by automated direct debit.
Discount - Pay on time	7% discount on daily supply charge and usage rates where you agree to receive invoices by email and full payment is received by an approved payment method by the due date.
Refer a friend	For each friend you refer during your agreement with us, you receive \$35 (including GST) referral credit and your friend also receives \$35 (including GST) sign up credit. There is no limit to the number of friends you can refer and therefore credits you can receive.

Fees

Credit card payment processing fee	0.60% (including GST), may be applicable if you choose to pay by Mastercard or Visa credit cards.
Dishonoured payment fee (cheque)	\$20 (including GST), may be applicable if payment is not honoured by your bank.
Dishonoured payment fee (direct debit)	\$10 (including GST), may be applicable if payment is not honoured by your bank.
Late payment fee	\$15 (including GST), may be applicable if payment is not received before the due date.
Establishment fee	\$22 (including GST), payable upon transfer to us from another retailer.

Solar Feed in Rate / Tariff

Feed-in Tariff: Distributor Funded	PFIT Scheme is closed to new solar-PV installations. Existing Solar-PV installations receiving PFIT will continue to do so as per scheme rules and where they maintain eligibility. DE Standard Rate will also apply to increase feed in rate to 72 cents/kWh for eligible PFIT participants.
DE Standard Rate	Customers with eligible Solar-PV systems will receive 12 cents/kWh for all export electricity (net metered only) subject to change as per the relevant Terms & Conditions. DE Standard Rate applies to solar-PV systems up to 10kW or as otherwise agreed in writing by us.
