- ^^ Residential GD and Controlled Load (Hot Water and Heating): The basic network tariff for general domestic usage such as lights and power outlets, and electric hot water and/or storage space heaters (only on for a controlled period generally between 11pm and 7am AEST) using a time-switch. Only available to residential installations currently taking supply under these rates.
