We will let you know before your benefit period expires what your options are. We may offer you another energy plan or a replacement contract. If you don't accept another offer from us before your initial energy plan expires, your rates and charges will become the same as our then current standing offer prices.

Price Changes	We may change your rates if the information we used to set the rates is incorrect, a new meter type is installed at your premises or your distributor changes the network tariff for your premises. We may also vary change your rates or charges, or apply a new charge to reflect actual or expected changes to any of the following costs: environment costs, market costs, metering costs, network costs, costs arising from changes in or under any law, wholesale costs, pass through charges and other costs we incur in connection with the purchase or sale of energy. We may also change your rates or charges, or apply a new charge for any other reason. We will give you written notice of changes to your rates and other charges. This notice may be in a message on your bill which you may receive after the effective date of the change. The details around when these changes may occur and the notice we will give you are also outlined in your Contract Terms and Conditions.

Eligibility Criteria	You are not eligible for our offer unless we have market contract rates for residential customers with your meter type in your distribution area. You must meet our credit worthiness and other eligibility criteria. Gas offers are only available in conjunction with an electricity offer and only if the supply address is connected for gas. You are eligible for this offer if you have Solar. The solar feed in tariff you will receive is based on the distributor's network tariff code.
