#### Vic Home E-Select

The retail tariff type that is available to you is dependent on the metering configuration at your premise. This meter configuration is defined by your relevant electricity distribution network, and may restrict the choice of retail tariffs available to you. For example, although you may currently have electric hot water, you may not be eligible for a controlled load hot water tariff.
