Feed-in tariff	Feed-in tariff is a cents per kWh rate paid for electricity fed back into the electricity grid by a solar PV system.

Contract Details

Eligibility	The offer set out in this Energy Price Fact Sheet is only available to residential electricity customers who consume less than 100 MWh/annum of electricity in the relevant distributor area with the necessary metering system/configuration. To be eligible for this offer you must purchase an eligible solar PV system from Origin. Total installed solar PV system capacity at your premises must not exceed 10kW. Your solar PV system must be net metered and you must not be receiving a feed-in tariff under any Government scheme. If you remove your solar PV system from the supply address during the benefit period the offer will continue but you won't receive the feed-in tariff.
Cooling off period	10 business days. You may cancel this contract at any time within the cooling off period.
