Feed-in tariff	Feed-in tariff is a cents per kWh rate paid for electricity fed back into the electricity grid by a solar PV system.

If you remove your solar PV system from the supply address during the benefit period the offer will continue but you won't receive the feed-in tariff.

Fees

Card payment fee	A 0.55% fee (GST Incl) may apply to payments made by VISA or MasterCard.
