Connection Fee	You will not be charged Energex's "standard" connection fee unless your property is connected via On The Move. A "standard" connection fee is \$10.98 (GST inclusive)
Disconnection Fee	You will be charged Energex's "standard" disconnection fee of \$8.76 (GST inclusive), when you move out of your property. This fee is passed through from your electricity distributor and is not a Click Energy fee.
Reconnection Fee	You will be charged Energex's "standard" reconnection fee of \$10.98 (GST inclusive)
Card Fee	You will be charged a fee of 0.6% (GST inclusive) of the payment amount when paying your bill by card. This charge will appear on your next bill
Late Payment Fee	You will be charged a late payment fee of \$12.00 (amount not subject to GST) if your bill is not paid in full by the due date. This charge will appear on your next bill.

Additional Information

Depending on your meter type you will be billed monthly, either actual meter reads, or, an instalment amount of \$50 (or otherwise agreed) which is then reconciled against your actual or estimated usage every quarter.
