Key terminology

Daily supply charge	Charge that applies for supplying electricity to your premises for each day of the billing period, regardless of how much electricity you use.
kWh	'kWh' stands for kilowatt hour and is the unit of measurement for your electricity usage charges.
KW	Demand is measured in kilowatts (kW) and is the maximum rate of electricity consumption over a 30 minute billing interval.

Price Changes

Charges may vary	During the benefit period we will not vary the usage, supply, capacity or demand charges, but may vary all other charges by notice to you. After the benefit period we may vary all components of the Charges by notice to you. This includes varying the amount, nature and structure of any of the charges. The notice may take the form of a message on your next bill and will specify the effective date of the variation.
