Reconnection fee	Up to - \$51.55 This amount is GST inclusive and may be charged when your distributor has to reconnect or read your meter to enable you to move into a property or change retailer.

Disconnection fee	Up to - \$51.55 This amount is GST inclusive and may be charged when your distributor has to disconnect or read your meter to enable you to move out of a property or change retailer.
Cheque dishonour payment fee	Fixed rate - \$6.50 A dishonoured payment fee is charged when AGL attempts to process a payment via cheque and receive a dishonour notification from your bank. This amount is not subject to GST.
Direct debit dishonour payment fee	Fixed rate - \$2.30 A dishonoured payment fee is charged when AGL attempts to process a payment via direct debit and receive a dishonour notification from your bank. This amount is not subject to GST.
Payment processing fee	Percentage of bill - 0.45% The amount is GST inclusive and applies to payments made by debit and credit cards.
