You must be a member of RAA at the time you enter into the electricity/gas contract. Members of equivalent motoring organisations in other Australian States and Territories or other countries are eligible. You must meet our creditworthiness and other eligibility criteria. Gas offers are available if the supply address is connected for gas.

Price Changes	We may change your rates if the information we used to set the rates is incorrect, a new meter type is installed at your premises or your distributor changes the network tariff for your premises. We may also change your rates or charges, or apply a new charge to reflect actual or expected changes to any of the following costs: environment costs, market costs, metering costs, network costs, costs arising from changes in or under any law, wholesale costs, pass through charges and other costs we incur in connection with the purchase or sale of energy. We may also change your rates or charges, or apply a new charge for any other reason. We will give you written notice of changes to your rates and other charges. This notice may be in a message on your bill which you may receive after the effective date of the change.
