Key terminology

Daily supply charge	Charge that applies for supplying electricity to your premises for each day of the billing period, regardless of how much electricity you use.

Feed-in tariff	Feed-in tariff is a cents per kWh rate paid for electricity fed back into the electricity grid by a solar PV system.

Eligibility	The offer set out in this Energy Price Fact Sheet is only available to customers in the relevant distribution area with the necessary metering system/configuration. To be eligible for this offer your solar PV system must be net metered and must not be larger than 10kW, and you must not be receiving a feed-in tariff under any Government scheme. If you remove your solar PV system from the supply address during the benefit period the offer will continue but you won't receive the feed-in tariff.
Cooling off period	10 business days. You may cancel this contract at any time within the cooling off period.

Solar feed-in tariffs	For the 12 month benefit period you'll receive a total feed-in tariff of 20 cents per kWh for every kWh of electricity exported to the grid. From 1 July 2018, the 20c/kWh is made up of our standard retailer feed-in tariff of 9.9c/kWh and an additional feed-in tariff of 10.1c/kWh. The 'Terms and Conditions for Feed-in Tariffs – Victoria' applies to both the additional feed-in tariff and standard retailer feed-in tariff. When the benefit period ends you'll receive our standard feed-in tariff available at the time your benefit period ends as published on our website. Origin offers feed-in tariffs.
