Key terminology

Daily supply charge	Charge that applies for supplying electricity to your premises for each day of the billing period, regardless of how much electricity you use.
kWh	'kWh' stands for kilowatt hour and is the unit of measurement for your electricity usage charges.
KW	Demand is measured in kilowatts (kW) and is the maximum rate of electricity consumption over a 30 minute billing interval.

Flexible Pricing Information	By choosing this tariff you may not be able to revert to your original tariff, but there will be a flat rate tariff available to you, except in some circumstances, which may include where you have a solar PV system.
