## Key terminology

Daily supply charge	Charge that applies for supplying electricity to your premises for each day of the billing period, regardless of how much electricity you use.
kWh	'kWh' stands for kilowatt hour and is the unit of measurement for your electricity usage charges.
KW	Demand is measured in kilowatts (kW) and is the maximum rate of electricity consumption over a 30 minute billing interval.
