VIC Home eSelect

The retail tariff type that is available to you is dependent on the metering configuration at your premise. This meter configuration is defined by your relevant electricity distribution network, and may restrict the choice of retail tariffs available to you. For example, although you may currently have electric hot water, you may not be eligible for a controlled load hot water tariff. Similarly, older premises may retain a meter configuration that is no longer available to more recently built premises. Moving house may mean you are unable to maintain the same tariff construct depending on how the respective meters are configured.

The billing details on the reverse side of your bill may help you identify your current meter configuration, however to ensure you are comparing the correct rates for your situation we recommend you contact our call centre to discuss the options available to you.
