

## Solar feed-in tariffs

Origin offers 10 cents per kWh until a daily export limit of 14 kWh is reached. The daily export limit is averaged across your billing period (calculated by multiplying the number of days in your billing period by your daily export limit of 14 kWh).

## Solar feed-in tariffs

For any amount above the daily export, you will receive our standard retailer feed-in tariff of 6.7 c/KWh. From 1 July 2021, the 11c/kWh is made of standard retailer feed-in tariff of 6.7c/kWh and additional feed-in tariff of 3.3c/kWh.

## **Controlled load consumption**

**Daily supply charge:** a charge that applies for supplying electricity to your premises for each day of the billing period, regardless of how much electricity is used.

kWh: a 'kWh' stands for kilowatt hour and is the unit of measurement for your electricity bill.

# **GreenPower options**
