For any amount above the daily export, you will receive our standard retailer feed-in tariff of 6.7 c/KWh. From 1 July 2021, the 10c/kWh is made of standard retailer feed-in tariff of 6.7c/kWh and additional feed-in tariff of 3.3c/kWh.
