Solar feed-in tariffs

The feed-in tariff component of this offer commences once the solar meter has been connected to the grid. During the benefit period you'll receive a total feed-in tariff of 12 cents per kWh for every kWh of electricity exported to the grid.

The 12 cents per KWh is made up of our standard retailer feed-in tariff of 6.7 cents per KWh and an additional feed-in tariff of 5.3 cents per kWh.
